TERMS AND CONDITIONS

ART. 1 PLACE AND DEVELOPMENT

PID-Dance Opportunities will take place on the 29th of April 2024 in Rieti, Italy.

ART. 2 AIM OF THE EVENT

The purpose of PID-Dance Opportunities is to offer dancers (aged 18 and over) and professionals the opportunity to get in touch with national and international classical and contemporary dance companies by organizing an audition in the presence of their artistic directors, choreographers or their representatives, in order to obtain, if deserving, employment contracts or internships, apprenticeships, participation in productions, galas, events.

ART. 3 REGISTRATIONS AND FEES

Subscription to PID-Dance Opportunities implies full acceptance of the regulations. This agreement is read and accepted when the candidate (or his legal representative) has completed the registration and received confirmation from our registration office.

ART. 4 COMMISSION

A commission made up of directors of national and international companies or their referents, choreographers or masters of great renown on the international dance scene will evaluate the candidates' abilities and their professional level. The candidate will be informed of the results by the e-mail address provided in the registration form. In the event if one or more members of the commission cannot be present at the various stages of the audition due to major forces or delays, the organization will replace them or proceed the event with the remaining members. The results are unappealable.

Dance Art Production & Events is not responsible about cancellation by Companies Directors, Companies Productions changes and in general about any decision take by Directors and Companies, even later the audition.

ART. 5 PRELIMINARY SCHEDULE

The Audition will consist in a ballet class follow by workshops held by the various choreographers, directors or representatives for selected companies. Candidates may be asked to present a solo based on the chosen discipline and the company they are applying for (classical for classical dance company, contemporary for contemporary dance company). The candidate must have a USB key with only the recording of the music file (mp3 format) of the variation presented. It could be ask to improvise. This schedule could have changes based on director, assistants etc's needs, during audition.

ART. 6 RESULTS

Candidates will receive the results of the Audition within 15 days through our organization by the e-mail which has been specified during registration. It will therefore be the responsibility of the candidate (or his legal representative) to verify that the information provided during registration are correct.
