ART. 1 DATES AND VENUE

The PID - Premio Internazionale Danza Città di Rieti will take place in Rieti, Italy, at the Flavio Vespasiano Theater **from April 22nd to April 25th, 2027.**

ART. 2 CATEGORIES (All ages are as of April 26th, 2027.)

SOLOISTS

CLASSICAL SOLOISTS:

Children: 10-13 years old (one free variation or one repertoire variation. Pointe shoes optional).

Juniors: 14-16 years old (one repertoire variation en pointe).

Seniors: from 17 years old (one repertoire variation en pointe).

MODERN/CONTEMPORARY SOLOISTS:

Children: 10-13 years old (one variation).

Juniors: 14-16 years old (one variation).

Seniors: from 17 years old (one variation).

ROUNDS:

- **The CHILDREN category will only perform during the final round with one variation.**
- **The JUNIOR and SENIOR category will perform during the semifinal and final round with one variation.**
- If there is a sufficient number of participants to divide the categories, they will be divided into male and female categories.

PAS DE DEUX/DUO:

Classical/Neoclassical: One category from 14 years old (one pas de deux from classical/neoclassical repertoire without * variations or one free classical/neoclassical duo).

Modern/Contemporary: One category from 14 years old (one pas de deux/duo).

- The PAS DE DEUX/DUO category will perform during the semifinal and final with one pas de deux/duo.

* Pas de deux variations may be presented in the classical soloist category with the relative registration and fee.

CHOREOGRAPHIC COMPOSITION:

CHOREOGRAPHIC COMPOSITION B: Up to 14 years old.

CHOREOGRAPHIC COMPOSITION A: From 15 years old.

- All styles (classical, neoclassical, character, contemporary, modern, hip-hop, etc.) are allowed in the CHOREOGRAPHIC COMPOSITION category, with a minimum of 3 dancers.
- **Choreographic Composition will only perform in the final round.**
- **The Choreographic Composition category is based on the arithmetic average of the ages of the competitors.**
- **All ages are as of April 26th, 2027.**

ART. 3 REGISTRATIONS PROCESS AND FEES

APPLICATIONS OPEN: December the 1st, 2026 - APPLICATIONS DEADLINE: March the 15th, 2027 or until sold out.

- **Application form** (downloadable from the website) completed in all parts;
- **Passport or ID card**;
- **Bank transfer receipt**;
- **A clean bill of health or a medical certificate for competition**;
- **Parental authorization for participation in the competition** (under eighteen years old) downloadable from the website;
- **1 headshot for soloists, pas de deux, and choreographers for Choreographic Composition**;
- **Furthermore for the Choreographic Composition**: choreographer's passport, passport, clean bill of health for each dancer and parental authorization for dancers under eighteen years old.
- N.B.: All documents must be submitted in **PDF** format. Photos can be in JPEG format.
- **MUSIC SUBMISSION: Music files (MP3) must be attached with the registration by March 15th, 2027, by e-mail to pid.musica@gmail.com** (or must be uploaded during the online application). **IMPORTANT:** Specify the title of the variation or choreography, the name of the competitor, category and if the variation starts with music. Musical file without these descriptions will not be considered.
- N.B.: Incomplete applications will not be considered.
- Music substitutions will not be permitted within the 30 days preceding the star date of competition.

- CHILDREN SOLOISTS: **€ 110.00**
- JUNIOR SOLOISTS: **€ 130.00**
- SENIOR SOLOISTS: **€ 130.00**
- PAS DE DEUX/DUO: **€ 240.00**
- CHOREOGRAPHIC COMPOSITION: **€ 50.00** per group + **€ 50.00** for dancer (example: a group of five dancers will pay € 50.00 + € 50.00 for each participant. Total € 300.00).

This application fee refers only to the competition. For masterclass fees, see Art. 9.

N.B.:

- It is permitted to participate with more than one variation or choreography in the same category, paying the relative registration fees for each variation or choreography.
- Travel, board, and lodging costs are on responsibility of the competitors.
- The Direction reserves the right to close applications if the maximum number of participants will be reached before the stipulated closing date. In this case, entry forms will be considered based on the date of arrival, on a first-come, first-served basis.
- Fees are only refundable in case of cancellation of the competition (see Art. 11).

ART. 4 ROUNDS AND FINAL GALA

A provisional timetable is available on the official website.

Check the timetable on the board during the event as the program may change. The Direction is not responsible if competitors do not read communications posted on the information board.

First, second, and third prizes from each category (or some competitors chosen by judges) will perform during the Final Gala. The Award ceremony for the winners and Special Prize recipients will take place at the end of the Gala.

Winners of institutional awards are required to attend the award ceremony in stage costume.

Recipients of a Special Award are kindly requested to wear formal or evening attire.

Participation in the final Gala is considered mandatory.

Any unjustified absence, unless supported by valid and documented reasons accepted by the Management, may result in the revocation of the assigned award.

SPECIAL AWARDS

Scholarships, mentions, and special prizes (**PID SPECIAL AWARDS**) may be awarded at the discretion of the jury based on the rounds and masterclass. These awards (including contracts, internships, scholarships, and special prizes offered by competition partners) will be given directly by the Jury, Authorities, and Direction.

ART. 6 CHOREOGRAPHY, TIME LIMITS, LIGHTS AND COSTUMES

SOLOISTS: maximum 2,30 minutes.

PAS DE DEUX/DUO: maximum 3,00 minutes for free choreography. For classical repertoire pas de deux, the maximum duration is as for the repertoire.

CHOREOGRAPHIC COMPOSITION: maximum 4,30 minutes.

N.B.: Please indicate **the exact timing of the choreography** in the registration form (time limits must include any silences).

Stage lights will be fixed in white.

Stage costumes are required for each round.

Scenic design or props are not allowed unless the objects are small, and in any case, they must be communicated in the registration form. Make-up, body creams, liquids, or powders that could stain or damage the dance floor are strictly prohibited. Violation of this rule will result in expulsion from the competition, and any damage to the dance floor will be responsibility of the offender.

Taking photos or videos is strictly prohibited.

Music, in MP3 format, must be attached to the registration form and sent to pid.musica@gmail.com (or uploaded during the online application process) **by 15th March 2027**, specifying the title of the track, the name of the competitor, the category and whether the variation starts with music or not.

All competitors must have their music on a USB key in MP3 format during the competition. This must be presented to the organizers if necessary. The judges reserve the right to reject recordings deemed unprofessional (e.g., with imperfections, background noise, rustling, etc.).

The organization declines any responsibility for the protection of the choreography presented. By applying, each participant declares they have all the necessary authorizations taking responsibility for the rights and/or ownership of the choreographies.

ART. 7. OPEN STAGE

Stage rehearsals/open stage will be assigned according to the daily plan, following the program order:

- **CHILDREN:** Open Stage for the final round.
- **JUNIORS:** Open Stage for the semifinal round.
- **SENIORS:** Open Stage for the semifinal round.
- **PAS DE DEUX/DUO:** Open Stage for the semifinal round.
- **CHOREOGRAPHIC COMPOSITION A and B:** One rehearsal with music for the finals, equal to the length of the choreography. Stage rehearsals are optional and MUST BE SPECIFIED in the application form.

The Direction reserves the right to change the above schedule.

Competitors will be called to rehearse on stage as update program. If competitors are not present when called for rehearsal, they will lose their opportunity to rehearse, and it will not be possible to reschedule at any other time.

Participants list will be available during the competitors registration.

Only one representative is allowed backstage.

Stage size: 11 x 16 meters, wooden, with a black dance floor (5% rake).

A provisional timetable will be available on the official website. The final timetable will be published closer to the event.

ART. 8 PANEL OF JUDGES

The judges' decisions are final and cannot be contested.

The jury may choose not to assign awards or may decide to award more prizes than those initially announced. If one or more members of the jury are absent, the organization will provide a substitute or continue the event with the remaining members.

ART. 9 MASTERCLASSES

Masterclasses will be organized during the competition.

They will be conducted by members of the competition's jury/teachers or other guest teachers.

Participation in the classes is not mandatory but is strongly recommended for a more comprehensive assessment and for educational purposes.

Participants in the Children Soloist, Juniors, Seniors, Pas de Deux/duo, and Choreographic Composition A & B categories may register, at their discretion, for the following classes:

- **Intermediate Ballet Level**
- **Advanced Ballet Level**
- **Intermediate Contemporary Level**
- **Advanced Contemporary Level**

Each participant, regardless of the competition section they are applying for (ballet or contemporary), may register for both classical and contemporary classes (level at their discretion).

APPLICATIONS OPEN: 1st DECEMBER 2026 - APPLICATIONS DEADLINE: 15th MARCH 2027 or until sold out.

For those who intend to attend only the classes, the cost of single masterclass is € 50.00.

- Fees are refundable only in case of cancellation of the masterclasses (see Art. 11).
- To attend the lesson, it will be necessary to wear the unique number that will be provided to you at the reception upon your check-in.

ART. 10 TICKETS AND GALA

The audience can attend the various rounds of the competition and the final gala by purchasing tickets at the box office of the Flavio Vespasiano Theatre during the competition days.

Semifinal and final tickets: € 12.00 each

Semifinal and final tickets for Pass Competitors or Pass Teacher: € 5.00 each

Gala tickets: € 20.00 each

ART. 11 CANCELLATION OF THE EVENT

The Direction reserves the right to cancel the event if there are not enough applications. In such cases, the application fee will be refunded. In the event that the competition cannot be held due to circumstances such as a pandemic, natural disaster, war, or other force majeure, the Direction may choose to hold the competition online or postpone the event. In these cases, fees are non-refundable.

The Direction may also decide to change the location, categories, sections, timetable, days, jury, classes, teachers, rehearsals, or any other aspect of the event. Fees will only be refundable by the Direction in the case of event cancellation.

ART. 12 DISCLAIMER

Competitors authorize the Direction to use images and personal data in accordance with Law 13 (D. Lgs. 196 of 30/06/2003) for promotional purposes and accept the rules and all articles stated.

For any matter not covered in these articles, the Direction's decisions are final. Unauthorized photos and videos are prohibited; only photographers accredited by the organization and provided with a pass are allowed to take photos and videos. Participants must check the timetable on the information board at the Theatre. By participating, each competitor accepts all the articles of PID's rules. Any damage caused to the structure, objects, or people during the event will be the responsibility of those who caused the damage.

This regulation may be subject to changes and/or updates; therefore, please always refer to the latest version of the published regulation.
